

Modification A to Contract #17-9







The modification to this agreement will be in effect from October 1, 2017 through September 30, 2018. The Provider agrees to abide by all of the terms of the original agreement dated October 1, 2017 through September 30, 2018 with addition of the following:

**Increase LIHEAP Crisis Client Services by \$46,614, resulting in a total allocation of of \$152,025**

**XII. COST AND SERVICES TO BE PROVIDED**


A. Provider and Purchaser understand and agree that the eligibility of individuals to receive the services purchased under this agreement will be determined by the Purchaser.
