

ORDINANCE NO. 2007-11

ORDINANCE BY THE FINANCE AND HUMAN RESOURCES COMMITTEE AMENDING VARIOUS SECTIONS IN CHAPTER 2 OF THE RACINE COUNTY CODE OF ORDINANCES RELATING TO DEPARTMENTS, DIVISIONS, OFFICERS AND EMPLOYEES

To the Honorable Members of the Racine County Board of Supervisors:

The Racine County Board of Supervisors does ordain as follows:

Part 1

Section 2-256 of the Racine County Code of Ordinances relating to the organizational chart is hereby amended as indicated on Exhibit "A" which is attached hereto and incorporated herein.

Part 2

Sections 2-282 of the Racine County Code of Ordinances relating to departments are hereby amended to read as follows:

Sec. 2-282. Corporation counsel.

There shall be an office of corporation counsel that is created pursuant to W.S.A., § 59.42. The corporation counsel shall be appointed by the county executive and confirmed by the Racine County board of supervisors. The corporation counsel may be removed by the county executive. county executive may remove the corporation counsel with the concurrence of the board of supervisors. The corporation counsel shall have the powers, duties and functions as set forth in W.S.A., § 59.42, which shall include giving legal counsel and opinions to the board of supervisors and its committees, approving all contracts of the county which have heretofore required the approval of the district attorney, and any duties required by state statute, county ordinance or resolution or the county executive. The corporation counsel shall prosecute actions to recover forfeitures for violations of county ordinances except for those cases that are assigned to the district attorney. The corporation counsel shall oversee the administration of the child support enforcement operations.

Part 3

Section 2-266(11) of the Racine County Code of Ordinances relating to departments is hereby deleted.

8 Section 2-303 of the Racine County Code of Ordinances relating to child support
9 is hereby amended to read as follows:

11 **Sec. 2-303. Child support.**

13 There is created an Office of Child Support Enforcement that operates under the
14 authority of W.S.A., § 59.53(5), and administers the program of child support, paternity
15 establishment, and medical liability support. The child support department is hereby
16 designated as the child support collection department pursuant to W.S.A. § 59.53(5m).
17 The Office of Child Support Enforcement shall be a part of the office of Corporation
18 Counsel.
