14 SUPERVISORS FOR THE YEAR 1969 as recodified May 28, 1991, by
15 Ordinance 91-196.

18 follows: Amend the Racine County Zoning Ordinance & change the
19 zoning district for the following described lands from P-1
20 Institutional Park District to A-2 General Farming & Residential
21 District II

23 PT SW ¼ COM CEN SEC, S325' TO POB, S102', W165', N102',
24 E165' TO POB

25 CONTAINING 00.39 acres, more or less. This rezoning shall
26 extend to the centerline of Caldwell Road.

29 The official Racine County Zoning Map is hereby amended to conform
30 to this ordinance.

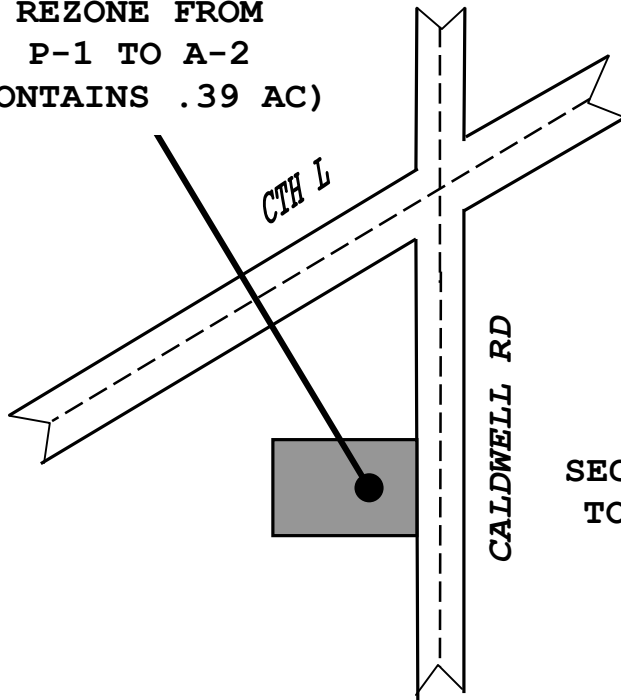
